Professorship

Established in 2008 with funding from McMaster's Department of Family Medicine, the goal of the **McMaster Family Medicine Professorship in Child Health Research** is to contribute significantly to the body of scholarship in the areas of primary care and child health, through teaching and research at McMaster University.

Acknowledgement

I would like to acknowledge and thank the Department of Family Medicine at McMaster. Under the leadership of Dr. David Price, the Department used their own financial resources in creating this professorship. In doing so, they have publically affirmed, in a very powerful way, their dedication and commitment to scholarship and research, and to creating a culture of academic excellence within their department. I am honoured to be the inaugural holder of this professorship, and to be a member of such a diverse and intellectually stimulating environment.

Focus

My work lies at the intersection between basic research, informed by disciplines such as population health/epidemiology, psychology and sociology, and applied clinical research. Fundamentally, I am interested in understanding the social, psychological and biological factors that influence health and health behaviours in a developmental context (change over time, with a focus specifically on childhood and adolescence). While research questions often begin framed as a basic science question, my interest in clinical relevance permeates the whole process, from conception through to dissemination (i.e., can this knowledge be used to improve the lives of individuals, families and communities/populations). This approach has resulted in many other research projects. However, the research within my overall program of work comes back to two general themes: (1) an interest in the interrelationships between physical and mental health in the developing child; and (2)

the epidemiology of mental disorders across the lifecourse. With regard to the former, my colleagues and I have built an internationally recognized program of research, specifically examining the impact of motor coordination problems (developmental coordination disorder), and the mental and physical health and well-being of those children. To the former, I have worked with large, population health databases (administrative and survey-based) to better understand the prevalence and determinants of major mental disorders (e.g., depression, social anxiety disorder) among the Canadian population.

Goals of the Professorship

When I assumed the role of professorship in 2008, I envisaged a program of research that would have national and international impact in the field of child health. I did, however, also want to make a significant contribution to the development of research and scholarship efforts within the Department of Family Medicine. As a leader in research for Family medicine, I felt that one critical role was to directly engage with external stakeholders (knowledge users, policy makers) to effectively disseminate and translate the knowledge we were producing. Broadly, my objectives were to:

- (1) Produce and disseminate, high-quality, high-impact scientific research in the fields of child health and psychiatric epidemiology, that is relevant to both basic science and clincial pracitce in family medicine and beyond.
- (2) Train the next generation of scientists in these and related fields. Mentor clinical colleagues interested in conducting research.
- (3) Actively participate in the governance of research in the department of family medicine. Work toward enhancing the academic culture of the department through collorboration with and mentorship of faculty and staff.
- (4) Actively engage with external stakeholders (knowledge users, policy makers) nationally and internationally to positively influence the uptake, use and dissemination of knowledge in the fields of child health and psychiatric epidemiology.
- (5) Become a recognized leader, nationally and internationally, in my respective fields of inquiry.

Relevance

My work in child health has focused primarily on the health consequences of developmental coordination disorder (DCD), a common (5-6% prevalence), yet unrecognized and poorly understood condition. My interest in developmental coordination disorder (DCD) has led to many novel, research projects that have led to new discoveries linking DCD to obesity, physical inactivity and early onset cardiovascular pathology. Moreover, we have also identified children with DCD to be at an increased risk of mental health problems, including depression and anxiety. As a result of our ongoing work, interest in the DCD population has grown

exponentially over the past five years. In the field of child health and development, motor development (typical and atypical) has emerged as a critical area of inquiry, making our work in DCD highly relevant to the field as a whole. Moreover, linking DCD to obesity has brought attention to the critical role that motor ability plays as a determinant of body composition. Concern over pediatric obesity in general makes our work both timely and relevant.

In addition to my work on DCD, I have continued to work in the area of mental health during my tenure in the professorship. Mental health and addictions are among the most pressing problems we face in our society. When my academic career began in 2002, mental health was not a priority issue for governments, nor a topic that attracted significant media attention and research dollars. This has fundamentally changed in the last 5 years. Priorities amongst government ministries have shifted towards understanding the prevalence, determinants and impact of mental disorders and addiction problems are a priority concern for policy makers and funding agencies. My work in psychiatric epidemiology is more relevant today than ever before. Recently, I was the co-lead of a commissioned report on the burden of mental illness and addiction in the province of Ontario (Opening Eyes, Opening Minds: The Ontario Burden of Mental Illness and Addictions Report). This study, which took over two years to complete, is the first of its kind to estimate years of life lost (both in relation to mortality and disability) attributable to mental disorder and addiction in Canada. These findings suggest that mental illness surpasses the burdens associated with both cancer and infectious diseases, and has garnered significant media attention and interest from policy makers in the province.

Accomplishments, Activities and Impact - Current Term

Below, I review my accomplishments, activities and impact as it relates to each of the stated objectives of the professorship stated above.

(1) Produce and disseminate, high-quality, high-impact scientific research in the fields of child health and psychiatric epidemiology, that is relevant to both basic science and clinical practice in family medicine and beyond.

These past 5 years at McMaster have arguably been the most productive period of my career. Specifically:

- I have been well-published:
 - o 1 book (as senior editor and contributor)
 - 5 book chapters
 - 1 conference proceeding
 - o 80 peer-reviewed journal articles (8 of these currently in press)
 - 12 peer-reviewed abstracts
 - o 6 reports
- I have received numerous sources of research funding:
 - o 6 peer-reviewed grants totaling \$5,739,133 as a PI or co-PI from national (e.g., CIHR) and provincial funders (e.g., MCYS)

- 25 peer-reviewed grants totaling \$7,271,077 as a Co-I from CIHR and SSHRC
- I have received confirmation of the impact of my work (these results show my biggest impact to the field has occurred during my tenure in the professorship):
 - According to Google Scholar, my h-index is 31 (25 since 2007), and my work has been cited more than 2,700 times, 2162 in the past five years. My i10 h—index (articles with at least 10 citations) is 62, 58 since 2007.
 - A bibliometric analysis published in 2008 ranked me 3rd among the top 20 most productive population health researchers in North America (Source: Trico et al., *Canadian Journal of Public Health*, vol 99(6): 466-71).
- (2) Train the next generation of scientists in these and related fields. Mentor clinical colleagues interested in conducting research.
 - In training the next generation of scholars, I have supervised 6 graduate students, 1 postdoctoral fellow, and have served on thesis committees for 19 others. As a mentor, I work to prepare my graduate and post-graduate trainees for entry into an increasingly competitive environment. All of my students work on, and receive financial support from, funded research projects. All are actively encouraged and mentored in working on publications and peer-reviewed national and international conference presentations.
 - Outside of McMaster, I have participated in supervisory committees at the University of Toronto and Brock University. I have been an external examiner of doctoral theses in Canada, Great Britain and Australia.
 - I have also been involved in mentoring peers from different countries. For example. Dr. Sheng Wu from the Institute of Sport Performance, National College of Physical Education in Taiwan spent his sabbatical with me in 2010-2011. Fully funded by a national endowment from Taiwan, he spent time to develop an international study between our two countries on cultural differences in the expression of physical activity deficit in children with DCD. Dr. Sheng's proposal is currently under review in Taiwan.
 - In 2012, I received a teaching award for mentorship in the Department of Clinical Epidemiology and Biostatistics.
- (3) Actively participate in the governance of research in the department of family medicine. Work toward enhancing the academic culture of the department through collaboration with and mentorship of faculty and staff.

While more difficult to quantify in comparison to number of publications and dollars for grants, I believe that I have had a very positive influence in the

Department of Family Medicine in my role as Professor of Child Health and Associate Director of Research. In my role as research director, and through my professorship in family medicine, I have worked hard to encourage a culture of research and scholarly inquiry among colleagues. This has been achieved through a number of initiatives:

- One example concerns my involvement with the maternity centre research group. Shortly after my arrival, I was able to reinvigorate this committee, resulting in the securing of external funding for a randomized control trial and numerous smaller studies.
- Another example is my work as *Chair* of the Early Years Committee in the
 Department of Family Medicine. This Committee is responsible for overseeing
 education and training in healthy child development for both the medical
 clerkship (undergraduate medical program) and the Family Medicine
 Residency training program.
- I have also mentored several colleagues in a number of different projects. Some examples include:
 - o I have mentored Dr. Joyce Zazulak, in relation to the evaluation of her innovative program in Art and Medicine
 - I provided mentorship and support to Dr. Tejal Patel, who successfully obtained a fellowship through the College of Family Medicine of Canada (Daniel Glazier Award in Adolescent Mental Health and Substance Abuse Research, awarded in 2012).
 - o Dr. Liz Shaw and I prepared a grant application for HAHSO funding (currently under review) to support her work on maternal/child health and addictions.
- (4) Actively engage with external stakeholders (knowledge users, policy makers) nationally and internationally to positively influence the uptake, use and dissemination of knowledge in the fields of child health and psychiatric epidemiology.
 - During my first term in the professorship, I have been a consultant to the government on policy related to mental health in children. Some examples include:
 - o I am the co-scientific lead on the evaluation of the child and youth mental health strategy of Ontario. This strategy is a multi-ministry initiative involving: Health and Long-term Care, Ministry of Child and Youth Services, Education, Justice and Community and Social Services
 - I am the lead consultant on the design and implementation of a new screening instrument for psychosocial risk, as part of the Ontario Ministry of Child and Youth Services' *Healthy Babies, Healthy Children* program.
 - I am the lead scientist on the 18-month enhanced well-baby visit program in the province of Ontario. Related to this, I secured funding

from the Ministry of Child and Youth Services to conduct a validation of the NDDS, a parent-reported survey that is used in primary care and public health to screen for developmental delay.

- (5) Become a recognized leader, nationally and internationally, in my respective fields of inquiry.
 - In addition to publications and impact indicators (h-index), my scientific accomplishments have been recognized by my peers in several other ways:
 - o In 2009, I was elected by my peers to be the President of the Canadian Academy of Psychiatric Epidemiology.
 - Also in 2009, I became *Chair* of the Psychosocial, Behavioural Determinants of Health Review Committee at CIHR, a position I continue to hold.
 - o The following year (2010), I was elected a *Fellow* of the American Psychopathological Association.
 - In 2011, I was an Active and Excellent Visiting Fellow (invited) of the School of Psychology and Speech Pathology at Curtin University in Perth, Australia.
 - o In 2012, I was elected to the position of Board of Directors, for the North American Society for Pediatric Exercise Medicine (NASPEM)
 - I was appointed to the editorial boards of two prestigious journals the Journal of Epidemiology and Community Health (BMJ Group) and BMC Pediatrics (BioMed Central).
 - In October of 2012, I was invited to be the inaugural Editor-in-Chief of a new journal, Current Developmental Disorders Reports, to be published by Springer.
 - I am a sought after speaker, having been an invited keynote or guest lecturer at 30 national and international conferences and research symposia

Objectives for Next Term

The broad, core objectives identified in previous sections will remain unchanged for the next term of the professorship. I outline here several examples of new projects/directions for the second term.

- I currently have a grant under review at CIHR (\$2.1 million over five years), outlining the plan for a prospective, cohort study of preschool children (ages 4 to 6) with motor coordination problems. This will be the first study anywhere in the world to prospectively examine the links between DCD, inactivity and obesity in very young children.
- I also plan to increase my work on the role of exercise and physical activity in relation to health outcomes. Two examples of this include:
 - We currently have another grant under review at CIHR that will use existing data to explore the impact of participation in physical activity over a continuous, 20 year period on mortality in a representative sample of Canadians.
 - o Specifically working with people in family medicine, I have initiated a primary care exercise medicine research group. This has led to the submission of a proposal to HAHSO (AFP) to explore an intervention using personal electronic medical records as a platform for increasing physical activity in sedentary patients in the context of primary care. I would like to further ramp-up this activity, building a broader program of research in this area.
